정치인이나 고위 공직자의 경우 엄격한 도덕성이 요구된다. 부패는 아직 우리 사회의 심각한 문제 중 하나다.

- A strict moral and ethical standard should be set up for leaders, especially politicians and high-ranking officials. Corruption is still one of the biggest issues of our society.
- Politicians and individuals at high levels of the government need to be held to a higher moral & ethical standard because corruption is omnipresent in this society.
- Corruption is still rampant in our society. A strict ethical code is needed for bureaucrats.

부정부패를 용납해서는 안 된다. 하지만 세상에 털어서 먼지 안 나오는 사람 없다. 능력도 중요하다. 비현실적으로 엄격한 도덕적 기준을 세우면 그런 기준을 만족시키는 사람은 극소수에 불과하고 결국 능력있는 사람이 배제되고 일할 사람이 없어지는 문제가 생긴다.

- We shouldn't tolerate corrupt leaders, but nobody's perfect. As a leader, one's capabilities are very important. If we set up too high of a standard, only a tiny group of people will be able to meet it. We may end up losing many competent people due to extremely high and unrealistic moral standards.
- If moral and ethical standards are set too high, they may eliminate more qualified candidates. There are a lot of skeletons in people's past, but that shouldn't exclude someone if they are able to get the job done.
- High standards may disqualify certain competent individuals whose moral compass does not always point north. People who know how to bend the rules are the ones that can get things done.

현실적인 도덕 기준을 세울 필요가 있다. 그리고 세운 기준을 엄격히 지켜야 한다. 그래야 사람들이 기준을 준수하고 우리사회가 좀 더 깨끗해질 수 있을 것이다.

- We need to set up realistic ethical standards for the leaders of our society. Once the standard is set up, it should be kept with no exception. Then people start to realize that living up to the standard is very important and our society will become less corrupt.
- The only way to get rid of corruption is to set an obtainable set of rules. If these rules are broken, immediate action should be taken to remove these people from office.
- There needs to be a zero-tolerance policy when it comes to corruption. When standards are set in place and are enforced, people will be forced to behave in an ethical manner.
